**SUB: INVITING QUOTATIONS FOR DESIGNING, PRINTING, TRANSPORTATION AND INSTALLATION OF
FACADE OF "PRADHANMANTRI KISAN SAMRIDHI KENDRAS" (PMKSK) IN SINDHUDURG DISTRICT ACROSS
VARIOUS VILLAGES**

We, Rashtriya Chemicals and Fertilizers Limited, a Govt of India undertaking intend to raise and install Model Fertilizer Retail Shop, which would be called "Pradhanmantri Kisan Samridhi Kendras" (PMKSK) at various villages of Sindhudurg District.

You are requested to kindly quote your lowest rate in the enclosed format, as per the following specifications, terms & conditions:

- **Overall job:** Designing, printing, transportation and installations of PMKSK FACADES with digital-Flex banner as per assigned enclosed list. Approximate number of FACADES is 156, which may vary as per the requirement. Each facade will carry approximate 56 to 60 sq. ft. area.
- **Designing and Printing:** Front Signage work i.e. designing of front facade with required color combination as per design provided by RCF, Printing should be on high grade star flex of 300 GSM material with minimum 4 pass multicolour printing. **(as per Annexure – I)**
- **Metal Frames Specifications:** The 1.00 X 1.00 inch Mild Steel (MS) square pipe having 24-gauge thickness.
- **Transportation:** The task of transportation of printed flex and metal frames at assigned village places across various blocks is contractor's sole responsibility and RCF will not be a part of that in any manner.

- **Installation:** The work of FACADE with star flex banner digitally printed board fitted with metal frame should be installed at various PMKSK centres as per the list enclosed which covers various District/Taluka/Villages places across Sindhudurg district. **(As per Annexure – II).**

Prequalification: The Service Provider of Flex printers and fabricators at district/taluka levels are not organized and may not be able to fulfill required prequalification criteria of tender guidelines. However, firm's registration certificate, work experience certificate in similar line of business during last 7 years, PAN of firm/proprietor, Bank Account details of firm/proprietor and GST certificate shall be submitted by service providers for prequalification. Service provider shall submit declaration on firm's letterhead, if GST is not applicable.

Other terms and conditions:

- The rate should be quoted on PER SQUARE FEET basis and quoted rates should be exclusive of applicable GST and inclusive of all expenditure like transportation, labour charges and final installations at District/Taluka/villages level as per the location given.
- The shop wise size of the facade has to be confirmed by you by visiting actual site before installation of the facade to make changes in size if necessary.
- The rates should be quoted in given format on your firm's letter head **(enclosed Annexure –III).**
- Final printing job should be done after obtaining draft approval from the company.
- Minimum one colour photograph having GPS location details like longitude and latitude. i.e. photographs before and after physical installation of PMKSK center facade along with bill should be provided.
- The work should be completed within 60 days of time period from the date of acceptance of work order.
- The installation of FACADE should be strictly as per the standard procedure and instruction given. The FACADE symmetry should be maintained for balanced visibility. An appropriate pasting method should be followed by the contractor for long term durability, no corner or border should remain un-pasted while installation. The due care of installation for symmetry and intactness should be taken by the contractor for more than one piece of MS frame units while installation at every site.
- The payment will be made against the actual measurements of work completed within 15 days, after completion of work against submission of GST Invoice with due satisfactory certification from concern RCF Officials. You may also submit the invoices in parts for the completed number of FACADES as per the specifications. The invoice should be supported with relevant work completion details and copy of photograph. NO ADVANCE PAYMENT WILL BE GIVEN.
- The requirement of **156 number** of FACADES and volume of **9360 Sq. Ft** work is only indicative. The area may get decrease/increase as per the demands and actual work done in the field. RCF does not give any guarantee of completing indicative area of FACADES.

- The contractor should ensure the fulfilment of FACADE quantities i.e. its production as per requirements given for every location/place during overall work completion time period.
- The production of FACADES should be quality consistent in overall supply. RCF will not entertain or accept any of produce which does not fulfil the product specifications as stated. RCF reserves the rights to cross verify the quality of material used, printing quality and installation. Any deviation reported shall be liable for rejection of particular site.
- The company is not responsible for any unforeseen circumstances happened/faced at any point of time during execution of this work at any place.
- The contractor will be responsible to appoint its own supervisor and workers for installation and completing works. RCF will not be responsible to provide representative while installation at any of location.
- After price-bid opening, negotiation will be carried out with L1 party.
- Company reserves all rights to accept all or reject any tender/s with/without assigning any reason thereof at any point of time.
